REGULATION (In accordance with the Article 11, Presidential Decree 26/10/2001, n° 430)

PROMOTER

Segni d'infanzia, cultural and artistic association – via L.C. Volta 9/b, 46100 Mantova – tax code/VAT number: 02225980206

CONTEST DURATION

from June the 10th 2016 to October the 10th 2016 until 11:59 pm

RECIPIENTS

The contest is open to students enrolled in any institution, from nursery school to high school, public or comprehensive, by any Country. Contestants can participate as single student or in a school class.

REGULATION ACCEPTANCE

By participating in the contest, the participant totally and unconditionally accepts the rules and the clauses written in the following regulation, without any limitations.

PARTICIPATION MODALITY

The participation is free and voluntary. The contest is dedicated to everyone who loves expressing his or her creativity.

Starting from the Animal Symbol, realize your own work of art; you can download the Animal from the homepage of Segni d'infanzia's web site (www.segnidinfanzia.org). There are no limits to creativity. It's possible to use paper or any other material, such as cardboard or wood, and turn it into a sculpture, or take a picture or film a footage; you can even complete it with a written work or a poetry you wrote by yourself.

So hey, **EXPRESS YOURSELF! We want to see your WOLF!!**

It's possible to join the contest in two different categories:

Art&Craft

Digital&Video

It's free to enroll for a category with one work or to enroll for both of them, with two distinct, participating as a single student or as a school class.

Art&Craft

The image of Animal Symbol can be transformed with paper, cardboard, wood, cloth and any other material you can think of for creating your wolf. Visiting the gallery of the previous editions on the web site www.segnidininfanzia.org is a way to find inspirations.

Single participants or school classes of all ages can sign up for Art&Craft by the dedicated web site; to certify the registration you will have to fill up a simple form with your data or the class's data, upload a picture of the work you realized and following deliver it to the office of Segni d'infanzia by via L.C. Volta 9/b, 46100 Mantua by October the 10th 2016. As for the material sent by post or courier, the reference date will be the date of shipping.

Digital&Video

the image of the Animal Symbol can be used as a starting point to realize an image or a digital work (picture – footage – written text – wall painting – cartoon bubbles – animation – conceptual art...); single participants or school classes from high schools can sign up for this category.

In order to confirm the participation, it's necessary to fill in the simple form with own data or the class's data and upload the video, the picture or the file created on the dedicated web site by October the 10th 2016.

The images uploaded on the dedicated web site will be shared on social networks (facebook) by the association Segni d'infanzia; the audience will be able to participate in the selection of the most creative works by expressing their preference and sharing the images they like the most.

Every participant or school class can enroll one single time for the category Art&Craft and one single time for the category Digital&Video.

The personal data given by filling up the enrollment form will be used for the participation in the current contest and for sending periodic newsletters with informative and promotional material about the activities by the association Segni d'infanzia.

The promoter association can not in any event be held responsible for any access problem, hindrance, malfunction or difficulty that could prevent users from accessing the service and participating in the contest.

SELECTION

The selection of the works will occur during the Segni festival 2016, taking place from October the 26th to November the 2nd.

The works will be exposed during the days of the festival in Mantova and visitors will have the opportunity to vote for their own favourite piece of work.

PRIZES

For each category (Art&Craft e Digital&Video) the jury will select:

1 school class – Free tickets for the whole class to attend a performance during SEGNI New Generations Festival 2017. The Art Direction will choose the performance in accordance with the availability of encores and the age of the winning class.

1 single participant – 3 tickets to attend together with his or her family a performance during SEGNI New Generations Festival 2017. The Art Direction will choose the performance in accordance with the availability of encores and the age of the winner.

The winner who will not be able or will not want to benefit from the free tickets will not obtain any amount of money. The prize cannot be changed with money or any other prize.

If the school class lives more than 150km away from Mantova, the festival direction will negotiate a special rate for the overnight.

Detailed conditions about the prizes fruition and the deliver modalities will be communicated directly to the winners after the win.

The prizes do not include transportation costs or any other expenditure, costs or service not expressly specified earlier.

For organizational reasons, the performance and the date and the time of the encore will be agreed with the administrative office of the festival in September 2017. After the emission of the free tickets, changing the encore will not be possible.

The winners can benefit from the prizes only during SEGNI New Generations Festival 2017.

If the winner class is attending the last year of school during the year 2016/2017, only in this case, Segni d'infanzia commits to organising a performance by the school of the winner class.

PRIZES CONFIRMATION MODALITY

On Wednesday, November the 2nd, the last day of the XI edition of SEGNI New Generations Festival 2016, the jury will gather and evaluate the pieces of work, considering the public votes. The jury will write a ranking with the first 10 works. The winners will be informed by December the 15th 2016 by email, using the email addresses given in the enrollment form.

Each winner will have to formally accept the prize **within 10 days** from the communication, sending by email the provided *Declaration of Acceptance/Renunciation of the Prize*, together with a copy of the ID Card, to the following address: segnidinfanzia@gmail.com. (the reference date will be the date of reading confirmation).

If the winner does not answer as explained, he or she will lose the right to the prize, that will be delivered to the runner-up.

PRIZES RENUNCIATION

In case of renunciation, the participant will have to confirm in writing his or her decision within 10 days from the winning communication, sending by email the Declaration of Acceptance/Renunciation of the Prize, together with a copy of the ID Card, to the following address: segnidinfanzia@gmail.com.

The renunciation or the lacking communication within the deadline will implicate the disqualification.

PRIZES AWARDING

The announcement of the win will be sent only to the contest winners by December the 15th 2016.

CONTEST PROMOTION

The promoter will promote the contest through its own website, social networks, mass media, promotional material and information by email. The advertising message will agree with what is written in this regulation.

THE BENEFICIARY ONLUS

The prizes which are not requested or not assigned, contrary to the refused ones, will be devolved to the Association Casa del Sole Onlus in Via Vittorina Gementi, 52 - 46010 S. Silvestro di Curtatone, Mantova (www.casadelsole.org).

PERSONAL DATA TREATMENT (ART. 13 Presidential Decree 196/2003)

In agreement with the the Presidential Decree dated June, the 30th 2003, n° 196 Code, about the protection of personal data (written below the "Code"), personal data will be treated by the Promotor, in the full compliance with the Code and the current regulations about privacy.

Segni d'infanzia, with the head office in Via L.C. Volta 9/b, 46100 Mantova, is responsible for the personal data treatment.

PROMOTER DECLARATIONS

The promoter cannot be held responsible:

- if winners contacted by the modalities written in this regulations can not

be found due to an incomplete or wrong data compilation requested for the participation;

- if winners do not answer to the announcement of the win sent by email;
- if contestants do not follow the instructions about the modalities of prizes delivery.

In case of clear and evident attempts to cheat and in case of wrong and false declarations, the Promoter will verify the correct participation to the contest and, in case of proven irregularities, the prize will not be delivered.

In case the winner is less than 18 years old, the promoter will ask for the parents' approval (or the approval of one legal guardian). If the written authorization is not sent by the deadline, the winner will be disqualified and the prize will be given to the second runner-up. If the winner decides to attend the performance with a minor, the promoter is discharged by any responsibility.
